

ORDINANCE No. 169

AN ORDINANCE OF CLYMER BOROUGH, INDIANA COUNTY and the Commonwealth of Pennsylvania, fixing the tax rate for the year 1973 and appropriating specific sums estimated to be required for specific purposes of the municipal government, herein after set forth, during the current year.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of Clymer Borough, County of Indiana Pennsylvania:

That a tax ~~and~~ be and the same is hereby levied on all property and occupations within the said municipality subject to taxation for the fiscal year 1973 as follows:

Tax rate for general purposes, the sum of 15 mills on each dollar of assessed valuation, or the sum of 150 cents on each one hundred dollars of assessed valuation.

Total rate of 15 mills on each Dollar of assessed valuation, or the sum of 150 cents on each one hundred dollars of assessed valuation.

SECTION 1. That for the expenses for the fiscal year 1973 the following amounts are hereby appropriated from the revenues available for the current year for specific purposes set forth below, which amounts are more fully itemized in the Budget Form.
