BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of the Borough of Clymer, County of Indiana Pennsylvania:

TAX LEVY ORDINANCE. No. 176
 AN ORDINANCE OF CLYMER BOROUGH, INDIANA COUNTY, and the Commonwealth of Pennsylvania, fixing the tax rate for the year 1974.
 BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of Borough of Clymer, County of Indiana, Pennsylvania
 That a tax be and the same is levied on all property and occupation within the said municipality subject to taxation for the fiscal year 1974.
 Tax rate for general purposes, the sum of 15 Mills or 150 cents on each one hundred dollars of assessed valuation.
 For debt purposes, the sum of 12 mills or 120 cwnts on wach 100 Dollars.
 A total of 27 mills on assessed valuation.
