

ORDINANCE NO. 267

AN ORDINANCE, OF THE BOROUGH OF CLYMER, COUNTY OF INDIANA AND COMMONWEALTH OF PENNSYLVANIA, INCREASING THE FINES FOR ILLEGAL PARKING WITHIN THE BOROUGH OF CLYMER.

BE IT ORDAINED AND ENACTED by the borough Council of the borough of Clymer, Indiana County, Pennsylvania, and it is hereby ordained and enacted as follows:

SECTION 1 - Fines for overtime parking shall be changed as follows:

- a. Second Offense -- from \$2.00 to \$5.00
- b. Third Offense -- from \$5.00 to \$10.00

SECTION 2 - Fines for parking within the prohibited areas near fire hydrants shall be increased from \$5.00 to \$15.00.

SECTION 3 - The fine for violation of parking requirements in handicapped zones shall be \$50.00.

SECTION 4 - All other fines shall be increased from \$5.00 to \$10.00.

SECTION 5 - Ordinance No. 89, as amended, shall otherwise remain in full force and effect.

SECTION 6 - This Ordinance shall become effective immediately.

WHEREAS, Clymer Borough is desirous of contracting with the county of Indiana through the Indiana County Office of Planning and Development to apply "on behalf of" Clymer Borough and to administer the program, and

WHEREAS, Clymer Borough is in agreement that the County of Indiana will be reimbursed for these services through the administration line item of the 1993 Community Development Block Grant Discretionary Program.

NOW, THEREFORE, BE IT RESOLVED THAT CLYMER BOROUGH agrees to sign a Cooperation Agreement with the County of Indiana to submit an application and administer the 1993 Community Development Block Grant Discretionary Program "on behalf of" Clymer Borough , and

BE IT FURTHER RESOLVED, that the Secretary of Clymer Borough is directed to execute a certificate attesting to the adoption of this resolution and to furnish a copy of the resolution to the Department.
