A RESOLUTION OF THE BOROUGH OF CLYMER FIXING THE RATE FOR THE
FISCAL YEAR 1995.

BE IT RESOLVED AND ENACTED by the Borough of Clymer and it is hereby
resolved and enacted as follows:

1. A tax be and the same is hereby levied on all property and occupation within the Borough of Clymer subject to taxation for Borough purposes for the year 1995 as follows:

Tax rate for general Borough purposes the sum of thirty (30) mills on each dollar of assessed valuation, making the total tax rate of all Borough purposes of thirty (30) mills.


2. A tax be and the same is hereby levied on all property within the Borough of Clymer subject to taxation for purposes of light and illuminating streets, highways, and other public places for the year 1995 as follows:


Tax rate for street lighting purposes the sum of eight (8) mills on each dollar of assessed valuation, making the total tax rate for street lighting purposes of eight (8) mills.
