ORDINANCE NO. 288

AN ORDINANCE OF THE BOROUGH OF CLYMER, COUNTY OF INDIANA AND COMMONWEALTH OF PENNSYLVANIA, VACATING AN UNNAMED ALLEY

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Clymer, County of Indiana and Commonwealth of Pennsylvania, and it is hereby ordained and enacted as follows:

1. That an unnamed alley extending in a western direction from Dixon Road for a distance of approximately 150 feet between Lots No. 79 and 80 on the official Borough Map also identified as Lots No. 15-06-439 and 15-06-440 on the Assessment records for Indiana County shall be vacated.

2. This ordinance shall become effective forty (40) days after passage.
