

ORDINANCE NO. 55

An Ordinance vacating certain portions of certain streets and certain alleys in the Borough of Clymer, Whereas, the Dixon Run Land Co., being the sole owner of all the abutting properties, has petitioned town Council to vacate certain portions of certain streets and alleys of the Borough. Hereinafter fully described, expressly waiving all claims for damages by reason of said vacation therefore.

Be it ordained and enacted by Town Council of the Borough of Clymer, County of Indiana and State of Pennsylvania, and it is hereby ordained and enacted by the authority of the same.

Section 1. That all that part and portion of a certain 16ft. alley in said Borough, beginning at the rear of lots #289 and 291 Hines Street and running thence in a northerly direction between said lots #289 and 291 one hundred twenty five feet to the line of said Hines Street, be and the same is hereby vacated.

Section 2. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the North line of Hines Street, and running thence in a northerly direction between lots #288 and 290 Hines Street ninety feet to a sixteen foot alley adjoining the right of way of the Cherry Tree and Dixonville Railroad be and the same is hereby vacated.

Section 3. That all that part and portion of a certain sixteen foot alley in said Borough beginning in said Borough at the North of Dixon Road and running thence in a northerly direction between lots #288 Dixon Road and an unnumbered parcel on said Road forty feet to a township road be and the same is hereby vacated.

Section 4. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the rear of lots #269 and 271, Hines Street thence running in a northerly direction between said lots #269-271 one hundred twenty five feet to Hines Street be and the same is hereby vacated.

Section 5. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the North side of Hines Street, and running thence in a northerly direction between lots #268-270 one hundred twenty five feet to a sixteen foot alley adjoining the right of way of the Cherry Tree and Dixonville Railroad be and the same is hereby vacated.

Section 6. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a ten foot alley adjoining the right of way of the Indiana County Street railway Company, and running thence in a northerly direction between lots #269-271 Dixon Road be and the same is hereby vacated.

Section 7. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the North side of Dixon Road and running thence in a northerly direction between lots #268-270 Dixon Road one hundred fifty feet to the rear of said lots #268-270 be and the same is hereby vacated.

Section 8. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a ten foot alley adjoining the right of way of the Indiana County Street railway Co. and running thence in a northerly direction between lots #233-235 Dixon Road one hundred twenty five feet to said Dixon Road be and the same is hereby vacated.

Section 9. That all that part and portion of certain sixteen foot alley in said Borough, beginning at the north side of Dixon Road and running thence in a northerly direction between lots #232-234 Dixon Road one hundred fifty feet to the rear of said lots #232-234 be and the same is hereby vacated.

Section 10. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a ten foot alley adjoining the right of way of the Indiana County Street Railway Co. and running thence in a northerly direction, between lots #215-217 Dixon Road, one hundred twenty five feet to said Dixon Road, be and the same is hereby vacated.

Section 11. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Dixon Road, and running thence in a northerly direction between an unnumbered parcel of land on the north side of Dixon Road and lot #216 Dixon Road twenty five feet to a township road be and the same is hereby vacated.

Section 12. That all that part and portion of a certain sixteen foot alley in said Borough, beginning on the line of land now or formerly of Kinter Bros., and running thence in a northerly direction between lots #1 and 3 Dixon Road fifty feet more or less to said Dixon Road; be and the same is hereby vacated.

Section 13. That all that part and portion of a certain fifty foot Street known and designated on the Borough plot or plan, as Rush Street beginning at the north side of a ten foot alley and adjoining the right of way of the Indiana Street Railway Company, and running thence in a northerly direction one hundred ten feet to Dixon Road, be and the same is hereby vacated.

Section 14. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a ten foot alley adjoining the right of way of the Indiana Street Railway Company and running thence in a northerly direction between lots #17 and 19 Dixon Road one hundred ten feet to said Dixon Road be and the same is hereby vacated.

Section 15. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Dixon Road and running thence in a northerly direction between lots #16 and 18 Dixon Road one hundred fifty feet to a sixteen foot alley running to the rear of said lots #16 and 18 be and the same is hereby vacated.

Section 16. That all that part and portion of a sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley running to the rear of lots #17 and 19 Sage Street, and running thence in a northerly direction between said lots #17 and 19 one hundred fifty feet to Sage Street be and the same is hereby vacated.

Section 17. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sage Street, and running thence in a northerly direction between lots #16-18 Sage Street one hundred fifty feet to a certain sixteen foot alley running to the rear of said lots #16-18, be and the same is hereby vacated.

Section 18. That all that part and portion of a certain fifty foot Street known and designated on the Borough plot of plan as Reed Street, beginning at the north side of a ten foot alley adjoining the right of way of the Indiana Street Railway Co. and running thence in a northerly direction one hundred feet to Dixon Road, be and the same is hereby vacated.

Section 19. That all that part and portion of a certain fifty foot Street known and designated on the Borough plot or plan as Reed Street, beginning at the north side of Dixon Road and running thence in a northerly direction one hundred fifty feet to a sixteen foot alley running to the rear of the lots on the north side of Dixon Road be and the same is hereby vacated.

Section 20. That all that part and portion of a certain fifty foot Street known and designated on the Borough plot or plan as Reed Street, beginning at the north side of a sixteen foot alley lying to the rear of lots on Sage Street and running thence in a northerly direction one hundred fifty feet to Sage Street be and the same is hereby vacated.

Section 21. That all that part and portion of a certain fifty foot Street known and designated on the Borough plot or plan as Reed Street, beginning at the north side of Sage Street and running thence in a northerly direction one hundred fifty feet to a sixteen foot alley running to the rear of lots located on the north side of Sage Street the same is hereby vacated.

Section 22. That all that part and portion of a certain 16 foot alley in said Borough beginning at the north side of a ten foot alley adjoining the right of way of The Indiana Street Railway Company and running thence in a northerly direction between lots #33-35 Dixon Road one hundred feet to Dixon Road, be and the same is hereby vacated.

Section 23. That all that part and portion of a sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley running to the rear of lots on the south side of Sage Street and running thence in a northerly direction between lots #33-35 Sage Street one hundred fifty feet to Sage Street, be and the same is hereby vacated.

Section 24. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sage Street and running thence in a northerly direction between lots #32 and 34 Sage Street one hundred fifty feet to a sixteen foot alley running to the rear of lots on the north side of Sage Street, be and the same is hereby vacated.

Section 25. That all that part and portion of a certain fifty foot street known and designated on the Borough plot or plan as Rodney Street beginning the north side of a ten foot alley adjoining the right of way of the Indiana County Street Railway Co. and running thence in a northerly direction ninety feet to Southerly line of Dixon Road, be and the same is hereby vacated.

Section 26. That all that part and portion of a certain fifty foot street known and designated on the Borough plot or plan as Rodney Street beginning at the north side of Dixon Road and running thence in a northerly direction one hundred fifty feet to a sixteen foot alley running to the rear of lots on the north side of Dixon Road, be and the same is hereby vacated.

Section 27. That all that part and portion of a certain fifty foot street, known and designated on the Borough plot or plan as Rodney Street, beginning at the North side of a sixteen foot alley running to the rear of lots on the south side of Sage Street and running thence in a northerly direction one hundred fifty feet to Sage Street be and the same is hereby vacated.

Section 28. That all that part and portion of a certain fifty foot street known and designated on the Borough plot or plan as Rodney Street beginning at the north side of Sage Street and running thence in a northerly direction one hundred fifty feet to a sixteen foot alley running to rear of lots on the north side of Sage Street be and the same is hereby vacated.

Section 29. That all that part and portion of a certain sixteen foot alley in said Borough beginning at the north side of a ten foot alley adjoining the right of way of Indiana County Street Railway Co. and running thence in a northerly direction between lots #49-51 Dixon Road seventy five feet to said Dixon Road, be and the same is hereby vacated.

Section 30. That all that part and portion of a certain sixteen foot alley in said Borough beginning at the north side of Dixon Road and running thence in a northerly direction between lots #48-50 Dixon Road one hundred fifty feet to a sixteen foot alley running to the rear of said lots #48-50, be and the same is hereby vacated.

Section 31. That all that part and portion of a certain sixteen foot alley in said Borough beginning at the north side of a sixteen foot alley running to the rear of lots 49-51 Sage Street and running thence in a northerly direction between said lots 49-51 one hundred fifty feet to Sage Street, be and the same is hereby vacated.

Section 32. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sage Street and running thence in a northerly direction between lots #48-50 Sage Street one hundred fifty feet to a sixteen foot alley running to the rear of lots #48-50 be and the same is hereby vacated.

Section 33. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the west side of Dixon Road and running thence in a northerly direction midway between Sage St. and Dixon Road two hundred sixteen across and to the least side of a sixteen foot alley lying to the west of lot #50 Dixon Road and lot #51 Sage Street, be and the same is hereby vacated.

Section 34. That all that part and portion of a certain sixteen foot alley in said Borough beginning at a ten foot alley adjoining the right-of way of the Indiana County Street Railway Co. and running thence in a westerly direction between lot #4 Dixon Road or (Stockton Street) and the rear line of lots laid out on the South side of Sage Street two hundred fifty feet to Stockton Street, be and the same is hereby vacated.

Section 35. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley located between lot #4 Dixon Road and the lots on the south side of Sage Street and running thence in a northerly direction between lots #65 and 67 Sage Street one hundred fifty feet to Sage Street be and the same is hereby vacated.

Section 36. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sage Street and running thence in a northerly direction between lots #64 and 66 Sage Street one hundred fifty feet to a sixteen foot alley running to the rear of lots on the north side of Sage Street, be and the same is hereby vacated.

Section 37. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at Dixon Road and running thence in a westerly direction between lots 72-74 and 75 Sage Street on the south, and lots #58-59 Dixon Road, on the North one hundred seventy five feet more or less to a sixteen foot alley running along the rear of lots on the west side of Dixon Road, be and the same is hereby vacated.

Section 38. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the west side of Dixon Road and running thence in a westerly direction between lots #63 and 64 Dixon Road one hundred fifty feet to an alley running to the rear of said lots #63 and 64, be and the same is hereby vacated.

Section 39. That all that part and portion of a certain fifty foot street unnamed on the Borough plot or plan, beginning at the west side of Dixon Road and running thence in a westerly direction between lots #67 and 68 Dixon Road and running one hundred fifty feet to a sixteen foot alley running to the rear of said lots #67-68 be and the same is hereby vacated.

Section 40. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the west side of Dixon Road, and running thence in a westerly direction between lots #71 and 72 Dixon Road, one hundred fifty feet to a sixteen foot alley running to the rear of said lots #71 and 72, be and the same is hereby vacated.

Section 41. That all that part and portion of a certain fifty foot street known and designated on the Borough plot or plan as Sixth Street beginning at the west side of Dixon Road and running thence in a westerly direction between lots #75 and 76 Dixon Road one hundred fifty feet to a sixteen foot alley running to the rear of said lots #75 and 76, be and the same is hereby vacated.

Section 42. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the west side of Dixon Road and running thence in a westerly direction between lots #79 and 80 Dixon Road one hundred fifty feet to a sixteen foot alley running to the rear of said lots #79 and 80, be and the same is hereby vacated.

Section 43. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the west of Dixon Road and running thence in a westerly direction between lots #95 and 96 Dixon Road one hundred fifty feet to a sixteen foot alley running to the rear of said lots #95 and 96 Dixon Road one hundred fifty feet, be and the same is hereby vacated.

Section 44. That all that part and portion of a certain fifty foot street, unnamed on the Borough plot or plan, beginning at the west side of Dixon Road, and running thence in a westerly direction between lots #99 and 100 Dixon Road, one hundred fifty feet to a sixteen foot alley running to the rear of said lots #99 and 100, be and the same is hereby vacated.

Section 45. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Jefferson Street, and running thence in a northerly direction between lots #50 and 52 Jefferson Street one hundred feet to a sixteen foot alley running to the rear of said lots #50-52, be and the same is hereby vacated.

Section 46. That all that part and portion of a sixteen foot alley in said Borough, beginning at the north side of Adams Street, and running thence in a northerly direction between lots #10-12 Adams Street one hundred fifty feet to a sixteen foot alley running to the rear of said lots #10-12, be and the same is hereby vacated.

Section 47. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street, being a continuation of the alley between lots #99 and 101 on the South side of Sherman Street, and running from the north side of Sherman St. twenty feet more or less to Twolick Creek, be and the same is hereby vacated.

Section 48. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street, and running thence in a northerly direction between lots #96-98 Sherman Street sixty feet more or less to Twolick Creek, be and the same is hereby vacated.

Section 49. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street, and running thence in a northerly direction between lots #76-78 Sherman Street one hundred fifty feet to an alley lying between the rear of said lots #76-78 and Twolick Creek, be and the same is hereby vacated.

Section 50. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street and running thence in a northerly direction between lots #64-66 Sherman Street one hundred fifty feet to an alley lying between the rear of said lots #64-66 and Twolick Creek, be and the same is hereby vacated.

Section 51. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street, and running thence in a northerly direction between lots #60 and 62, Sherman Street, one hundred fifty feet to an alley lying between the rear of said lots #48 and 50 and Twolick Creek, be and the same is hereby vacated.

Section 52. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street, and running thence in a northerly direction between lots #48 and 50, Sherman Street, one hundred fifty feet to an alley lying between the rear of said lots #48 and 50 and Twolick Creek, be and the same is hereby vacated.

Section 53. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street, and running thence in a northerly direction between lots #44 and 46 and Twolick Creek, be and the same is hereby vacated.

Section 54. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street, and running thence in a northerly direction between #32 and 34, Sherman Street, one hundred feet to Twolick Creek, be and the same is hereby vacated.

Section 55. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Sherman Street, and running thence in a northerly direction between lots #28 and 30 Sherman Street, fifty feet more or less, to Twolick Creek, be and the same is hereby vacated.

Section 56. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley at the rear of lots laid out on the south side of Sherman Street, and running thence in a northerly direction between lots #99 and 101, Sherman Street, one hundred fifty feet to said Sherman Street, be and the same is hereby vacated.

Section 57. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley lying to the rear of the lots laid out on the south side of Sherman St. and running thence in a northerly direction between lots #95 and 97, Sherman Street, be and the same is hereby vacated.

That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley lying to the rear of the lots laid out on the south side of Sherman Street, and running thence in a northerly direction between lots #27 and 29, Sherman Street, one hundred fifty feet to said Sherman Street, be and the same is hereby vacated.

That all that part and portion of a certain fifty foot street, known and designated on the Borough plot or plan as Second Street, beginning at the north side of an alley lying to the rear of the lots laid out on the south side of Sherman Street, and running thence in a northerly direction, one hundred feet, more or less to Twolick Creek, be and the same is hereby vacated.

Section 60. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Franklin Street, and running thence in a northerly direction between lots #28 and 30, Franklin Street, one hundred and fifty feet to a sixteen foot alley running to the rear of said lots 28 and 30, be and the same is hereby vacated.

Section 61. That all that part and portion of a fifty foot street, known and designated on the Borough plot or plan as Second Street, beginning at the north side of Franklin Street, and running thence in a northerly direction, one hundred fifty feet to a sixteen foot alley running to the rear of lots on the north side of Franklin Street, be and the same is hereby vacated.

Section 62. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north of Walcott Street, and running thence in a northerly direction between lots #32 and 34, Walcott Street, one hundred fifty feet to a sixteen foot alley running to the rear of said lots #32 and 34, be and the same is hereby vacated. ✓

Section 63. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Williams Street, and running thence in a northerly direction between lots #76 and 78, Williams Street, one hundred fifty feet to a sixteen foot alley running to the rear of said lots #76 and 78, be and the same is hereby vacated.

Section 64. That all that part and portion of a certain fifty foot street known and designated on the Borough plot or plan as Walcott Street, beginning at the east side of First Street, and running thence in an easterly direction, two hundred fifty feet, more or less, to Twolick Creek, be and the same is hereby vacated. +

Section 65. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Williams Street, and running thence in a northerly direction between lots #64 and 66, Williams Street, one hundred fifty feet to a sixteen foot alley running to the rear of said lots #64 and 66, be and the same is hereby vacated. ✓

Section 66. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Williams Street, and running thence in a northerly direction between lots #60 and 62, Williams Street, one hundred fifty feet to a sixteen foot alley running to the rear of said lots #70 and 72, be and the same is hereby vacated. ✓

Section 67. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley running to the rear of lots laid out on the south side of Walcott Street, and running thence in a northerly direction between lots #47 and 49, Walcott Street, one hundred fifty feet to said Walcott Street, be and the same is hereby vacated.

Section 68. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley running to the rear of lots laid out on the South side of Walcott Street, and running thence in a northerly direction between lots #43 and 45, Walcott Street, one hundred fifty feet to said Walcott Street, be and the same is hereby vacated.

Section 69. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of a sixteen foot alley running to the rear of lots laid out on the South side of Walcott Street and running thence in a northerly direction between lots #15 and 17, Walcott Street, one hundred fifty feet to said Walcott Street, be and the same is hereby vacated.

That all that part and portion of a certain sixteen foot alley running in said Borough, beginning at the north side of a sixteen foot alley running to the rear of lots laid out on the south side of Walcott Street, and running thence in a northerly direction between line along rear of lots #1, 3, and 5, First Street, and lot #13, Walcott Street, one hundred fifty feet to said Walcott Street, be and the same is hereby vacated.

That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Williams Street, and running thence in a northerly direction between lots #48 and 50, Williams Street, one hundred fifty feet to a sixteen foot alley running to the rear of said lots #48 and 50, be and the same is hereby vacated.

That all that part and portion of a certain fifty foot Street, known and designated on the Borough plot or plan as First Street, beginning at the north side of a sixteen foot alley running to the rear of lots laid out on the south side of Williams Street and adjoining lot #17 on First Street, and running thence in a northerly direction, one hundred fifty feet to its intersection with Williams Street at the extension of the Southerly line then be and the same is hereby vacated.

That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the Borough line, and running thence in a northerly direction between lots #76 and 78 Ross Street, one hundred twenty feet, more or less, to a sixteen foot alley running to the rear of the lots laid out on the north side of Ross Street, be and the same is hereby vacated.

Section 82. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the north side of Ross Street, and running thence in a northerly direction between lots #64 and 66, Ross Street, one hundred Fifty feet to a sixteen foot alley running to the rear of said lots #64 and 66, be and the same is hereby vacated.

Section 83. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the Borough line, and running thence along the East side of lot #50, Ross Street, fifteen feet, more or less, to a sixteen foot alley running to the rear of lots laid out on the north side of Ross Street, be and the same is hereby vacated.

Section 84. That all that part and portion of a certain sixteen foot alley in said Borough, beginning at the Borough line, and running thence along the east side of lot #50, Ross Street, fifteen feet, more or less, to a sixteen foot alley running to the rear of lots laid out on the north side of Ross Street, be and the same is hereby vacated.

Section 85. That within ten days, after approval of this ordinance, notice shall be given by hand bills posted along the lines of the ^{so} purpose improvements, stating the fact and date of passage of this ordinance, that the petition therefor was signed by a majority in interest and number of owners abutting and that any person interested and denying the fact that the petition was not signed may appeal to the Court of Common Pleas of Indiana County within thirty days after the passage hereof.

Section 86. That the map or general plan of the Borough be and hereby is changed, modified and amended in accordance with the various sections of the ordinance as above described.

Section 87. That all ordinances or parts of ordinances inconsistent herewith are hereby repealed.
